I, Marie Agnes Doyle, of 3/121 Bernina St Wynnum 4148, in the State of Queensland,  
make oath and say that :-

1. I am a retired teacher.
2. I worked at the Logan Village school as a colleague teacher with William Theodore D'Arcy from from August 1970 until May 1972.
3. I never witnessed any sexual misconduct by William Theodore D'Arcy.
4. I was harassed by the Argos police task force, especially Sergeant Stuart Kerlin, at least six times to make a witness statement accusing William Theodore D'Arcy of sexual misconduct, which I refused to do.
5. The police pressure on me made me ill to the point where I had to spend several days in bed.
6. I have reviewed the statement by Name PROVIDED wherein, believing me to be dead, she claimed I was a witness to sexual misconduct. I totally reject the assertion.

7. I have reviewed the statement by Name PROVIDED that she was sexually assaulted every week on average for six months. I declare that the Logan Village school was an open "chaotic" school and that no place existed wherein a teacher could engage in consistent or prolonged sexual misconduct, as described in detail by Debra Ann Lee (nee Spann), without being seen. (Statement 22-7-98 p.4 para 21)
8. I have reviewed the statement by Name PROVIDED that the last occurrence of sexual abuse ceased on her birthday on or about August 9, 1971. I state that on that date in that year the school was closed for school holidays and no students or teachers were present. (Statement 22-7-98 paras 2 and 21).
9. I state that I also taught Michael Kaiser, who later opposed William Theodore D'Arcy, for the state seat of Woodbridge.
10. When questioned by the police or any authority I have always stated that I believe that William Theodore D'Arcy is completely innocent of all the charges of which he was convicted.

ALL the facts and circumstances herein deposed to are within my own knowledge and belief .save such as are deposed to from information only and my means of knowledge and source of information appear on the face of this my affidavit.
